What is the purpose of rental (birthday party, business promoting etc.):

The scooter rides can only be used on a flat surface such as a road, cement pad, floor, or tennis court type thing. They do not climb slopes and have no breaks. They do not go overly fast, so when the accelerator is released, they will travel a little, and then stop. They are made of soft foam, so even if they hit a wall, they will be fine and ready to go again. Do not drive backwards. Small scooters will not hold adults, large ones will. Kids 9 and up can only ride large scooters. They can tip over if you turn too sharply. Absolutely no running into each other or running into stationary items.

We do not rent for outdoor use if it is raining or snowing.

Each ride will have a \$500 dollar deposit and refunded when brought back or picked up in good working condition. If renting multiple dinosaurs, Deposit will be at a maximum of \$1000.

unit roars and growls, wags tail, but does not rock back and forth. Pickup only unless ordering larger units at the same time. 1 available only



___ Rent an animatronic T-rex ride. \$75 for the first hour, \$25 for each additional hour. Half size, for younger riders. This unit roars and growls, wags tail, but does not rock back and forth. Pickup only unless ordering larger units at the same time. 1 available only



___ Rent an animatronic shoulder puppet dragon. \$30 per hour. He roars and growls and blinks his eyes as you control all the action. Pickup only unless ordering larger units at the same time. 1 available only



___ Rent an animatronic T-Rex Riding costume. \$75.00 per hour, \$40 for each additional hour. Pickup only unless ordering larger units at the same time. 1 available only



___ Rent an animatronic baby T-Rex in an egg dinosaur. \$25.00 per hour. - \$500 deposit refunded when returned or picked up. Pickup only unless ordering larger units at the same time. 1 available only



___ Rent an animatronic Triceratops ride. \$200.00 for the first hour, \$50 for each additional hour. We deliver and pick up this unit as it is large and heavy. Delivery Charges below. Full size - For Brave riders. The stairs 5' 9" x 2' 7" x 6'. The size of the dinosaur is 10.5' x 3.5' x 5'. This unit is fully automated, and rocks back and forth. 1 available only

RENTAL TERMS AND CONDITIONS

1. Payment in full is required to keep your booked date of rental. First to book and pay gets the date/times.

2. Deposits must be paid 1 day in advance of rental.
3. You can cancel with a full refund, 1 week prior to booking date. 50% will be refunded if cancelled within 24 hours of the reservation date. No refund thereafter.
4. A scan of a valid driver's license with a current address is required.
5. A credit card is necessary for the rental terms.
6. The renter shall keep and maintain the rented equipment during the terms of the rental at his own cost and expense. He shall keep the equipment in a good state of repair.
7. If it is Raining out, the dinosaurs must have a roof over them. We will supply a tent if required, you set up. Scooters must not be used outdoors when it is raining or snowing.
8. The renter shall pay the owner full compensation for replacement and/or repair of any equipment which is not returned because it is lost or stolen or any equipment which is damaged and in need of repair to put it into the same condition it was in at the time of rental, normal wear and tear excepted. The owner's invoice for replacement or repair is conclusive as to the amount renter shall pay under this paragraph for repair or replacement. \$13,000.00 maximum, but some dinosaur's costs are less than this amount.
9. The renter shall not remove the equipment from the address of the renter, or the location shown herein as the place of use of the equipment without prior written approval of the owner. The renter shall inform the owner upon demand of the exact location of the equipment while it is in the renter's possession.
10. The equipment shall be picked up by the renter and returned to the owner at the renter's risk, cost, and expense, unless we are delivering. If a periodic rental rate is charged by the owner, rental charges are billed to the renter for each period or portions of the period from the time the equipment is picked up by the renter until its return. If a term rental rate is charged by the owner, rental charges are billed to the renter for the full term even if the equipment is returned before the end of the term. If the equipment is not returned during or at the end of the term, then the rental charges shall proceed on a full-term basis for any additional term or portion thereof until the equipment is returned.
11. No allowance will be made for any rented equipment or portion thereof which it is claimed not to have been used. Acceptance of returned equipment by the owner does not constitute a waiver of any of the rights the owner has under the rental agreement.
12. The renter shall allow the owner to enter the renter's premises where the rented equipment is stored or used at all reasonable times to locate and inspect the state and condition of the rented equipment. If the renter is in default of any of the terms and conditions of this agreement, the owner, and his agents, at the renter's risk, cost and expense may at any time enter the renter's premises where the rented equipment is stored or used and recover the rented equipment.
13. The renter shall not pledge or encumber the rented equipment in any way. The owner may terminate this agreement immediately upon the failure of the renter to make rental payments when due, or upon the renter's filing for protection from creditors in any court of competent authority.
14. The owner makes no warranty of any kind regarding the rented equipment, except that the owner shall replace the equipment with identical or similar equipment if the equipment fails to operate in accordance with the manufacturer's specifications and operation instructions. Such replacement shall be made as soon as practicable after the renter returns the non-conforming equipment.
15. The renter indemnifies and holds the owner harmless for all injuries or damage of any kind for repossession and for all consequential and special damages for any claimed breach of warranty.
